3. SM Sailing Grand Prix Proposals (Rob Hurd)

- 1) **Schedule:** The schedule for 2021 will be the 2020 schedule.
 - Clubs that were planning on hosting a GP regatta in 2020 should not be penalize because of the pandemic.
 - Staying with 2020 will allow for a thorough review of the present 2018-2023 schedule. I am curious how well the two-day Hyannis Youth Invitational is this year and whether it should be included as a C420 and/or an Opti regattas in 2022. Staying with the 2020 schedule will allow time for this review.
 - A proposed 2022-2030 schedule will be presented in the fall for review.

QUESTIONS: Can you look at the C420 schedule? With two regattas slated on the island and no housing being offered, is problematic for non-island clubs?

ANSWER: Agreed. Rob will investigate adding a C420 regatta. BJR will be added to 2021 schedule and best 3 of 5 will be the standard this year

- 2) **420 Scoring**: Sailors in the 420 class will be score regardless of their position in the boat. They will be awarded trophies (1st through 5th) depending on which position they sailed most of the time.
 - This fixes the issue where a skipper-crew combination switch places for one regatta during the summer. Under our present system, they both lose out on points. Since we proscribe that both positions are vital to a boat's success, it should not matter which position you are in to be scored points.
 - Recognition of both skippering and crewing excellence is important. Rather than just have one big list, we should recognize excellent in both position as they require different skill sets. This keeps that recognition in place.
 - This proposal has a sunset clause through the 2022 season and would need to be reaffirmed before the 2023 season to take permanent hold.

- 3) **Overall scoring**: Only sailors that finish in the top 40 boats of a Grand Prix Regatta will be scored. In the case of the Opti class, if the top five in any division (red, blue, white) has not be scored in the top 40 boats, then next eligible boats in that division will be scored until a total of five is reached.
 - Design of the Grand prix is to recognize the best in each fleet. Scoring everyone is time consuming and slows the posting of accurate results.
 - Not scoring in a regatta may convince a sailor to attend another regatta in order to accrue points, which helps all of our regattas. This policy may lead to expanding the number of GP regattas for the 2022- 2030 schedule.
